All components are organic in nature and non-toxic, non-corrosive, and non flammable. Product contains no pigments, paints, solvents, base metals or metallic coatings. Product is Non Hazardous, Non toxic, Non Caustic, Non Acidic. Product is technically superior for cleaning all metal surfaces in the removal of Hydrocarbons, light to medium weight oils, dirt, grime, rouges, and various organic and non organic particulate from the metals surface without harm to the surface. Product ingredients are proprietary and withheld as a trade secret. Ocular (eye) Irritation: Method used in accordance with the method described in the Federal Hazardous Substance Act, 16 CFR, Section 1500.42. Summary of testing:

The submitted material, when tested produced minimal conjunctival irritation with no positive responses which cleared by day 4. Therefore, the test material would not be considered a primary eye irritant as defined by the Federal Hazardous Substance Act, 16 CFR, Section 1500.3 (C) (4). Note: test scores attached.

Primary Dermal Irritation: The submitted material, when dosed as supplied produced well defined to severe erythema with eschar formation and blanching, flaking, and/or cracking skin sites and very slight to moderate edema. The Primary Irritation score was a 4.09. The test material has the potential for severe irritation under occluded test conditions, however it would not be classified as a primary skin irritant as defined by the Federal Hazardous Substance Act 16 CFR, Section 1500.3 (c) (4). Note : Test scores attached.

Acute Oral Toxicity: The submitted test material, when administered as supplied at a single oral dosage level of 5gm/kg body weight, did not produce compound related mortality; therefore, the test material is not considered toxic according to definitions listed in 16 CFR 1500.3 (c) (1).
